 - vii. Russ political materials create tension

 - 2. If not, what is the action/response?
 - ix. Nathan we are an autonomous meeting and we can set particular rules; dealing with AA as a whole, so do these things interfere with delivering the message to anyone? If so, we're talking about turning off or not allowing images, as opposed to removing anyone.

**Motion / Nathan - from now until the election, profile pics of a political nature, are NOT allowed as they are deemed distracting. If/when seen, the host can act: (1) communicate with the participant about turning it off themselves or switching it, or (2) the host will turn it off. we turn off profile pics. This also applies to backgrounds. This does NOT apply to anything physically on the person's body i.e. clothing, tattoos, body mods, etc.
